*RULES AND REGULATIONS
LITTLE MISS FALL FESTIVAL PAGEANT*

EACH CONTESTANT MUST:

1. Be a female currently attending Coweta Public Schools and/or a resident of Coweta, Oklahoma.
2. Be at least five to six years of age on/or before the day of the pageant, but not over six years of age.
3. Not be a previous winner of the Little Miss Fall Festival Pageant.
4. Provide her own transportation to and from activities.
5. Be able to attend all activities preceding the Pageant.
6. Make every effort to attend all activities sponsored by the Chamber of Commerce. A **minimum** participation of 80% is required. Attendance will be checked quarterly and if attendance is below the required 80%, she will be asked to give up her title and any unused prizes. The first runner-up will be asked to assume the title for the remaining activities, and must also conform to the attendance requirements.
7. Must not have engaged in any activity, which, by community standards, could be characterized as dishonest, immoral, immodest, indecent, or in bad taste.

PLEASE NOTE:

No Little Miss Fall Festival contestant may change her wardrobe during the pageant unless she will be performing a gymnastics routine and has prior approval from the pageant committee and/or director. If you feel your child's talent presentation mandates a costume change please submit your request in writing along with this application. A committee will review your statement and you will be notified of our decision before the orientation. If the committee decision is **not** to allow your child to change you will have the opportunity to withdraw from the pageant. Unfortunately, any contestant who changes wardrobes during the pageant without permission from the committee and/or director will be disqualified from the talent portion of the pageant. Also, after the contestants' guardians have left her with the pageant staff, there will be **NO** interaction with the child until the pageant is over. Any girl who must change her wardrobe will have staff on hand to help her.

I have read and understand the rules and regulations cited above. Should I agree to submit my resignation as Little Miss Fall Festival or become unwilling or unable to comply with the above rules and regulations, I will return any unused prizes and will hold the pageant and committee and its members harmless from any liability, which may arise, from failure to comply with these rules and regulations.

- ☼ No late entries will be allowed.
- ☼ No entries will be taken via the telephone.
- ☼ The winner of the 2011 Little Miss Fall Festival Pageant must attend all Coweta Chamber of Commerce sponsored activities, per the Chamber Director. A minimum of 80% participation is required or the winner must give up her title and the first runner-up will assume the Little Miss Fall Festival duties.
