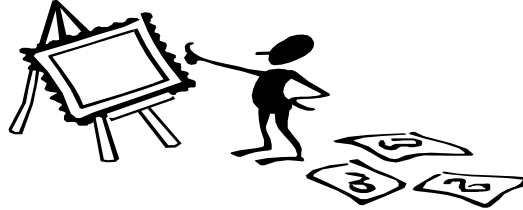


COWETA FALL FESTIVAL SEPTEMBER 15, 16, and 17, 2011

ARTS & CRAFTS and COMMERCIAL BOOTH RULES AND REGULATIONS



DEADLINE: Deadline for accepting applications is Friday, Sept 9, 2011

SPACE FEE: Flat fee of \$150.00 (For Profit) for each 10' x 10' space. No commission charges on sales.
Flat fee of \$75.00 (Non-Profit) for each 10' x 10' space. No commission charges on sales.

ELECTRICITY: Each 10' x 10' space shall receive one plug on a 110 outlet. Booth participants must supply their own power cord.

SHARING SPACE: You may share one (1) space with approval of the FALL Festival 2011 Coordinator.

REFUNDS: **NO refunds given for cancellations or change in the weather.**

SET-UP: Set up will begin Wednesday, September 14th- 4 p.m. Exhibitors must furnish their own tables, chairs, easels, tent and other display equipment. FALL FESTIVAL 2011 does not have any of these items to rent. We provide the space and electricity.

RESTRICTIONS OF SALE OF CERTAIN ITEMS: No knives, guns, t-shirts with sexual content, or any other merchandise of an offensive nature. **ALSO NO FOOD CAN BE SOLD FROM ARTS AND CRAFTS BOOTH.**

ASSIGNMENT OF SPACES: Assignment is on FIRST COME basis. Spaces will be assigned by the post mark date of application received with payment.

SALES TAX: Each vendor is responsible for his/her own sales tax.

PROPER CLEAN UP: It is expected during and after the **FALL FESTIVAL** you leave your assigned space(s) as you found it.
